2.0 - Introduction & Product Information

This equipment has been designed and manufactured to exceed confined space requirements and regulations in order to meet the needs of the discriminating operator for efficiency and safety during confined space entry operations.

Safe, efficient and trouble-free operation and maintenance of the system requires that anyone who will be operating, maintaining, or inspecting the equipment, read, understand and follow all the operation, safety, maintenance, and inspection instructions contained within this manual. This manual covers the Pelsue Model #1453 Centrifugal Blower. Use the Table of Contents as a guide to find specific information.

Keep this manual available for future reference if required, and as a tool in the training of new operators.



This product is a part of a system for confined space ventilation operations. The user must read, understand and follow the instructions contained in this manual before using this equipment. Failure to follow these instructions could result in serious injury or death.

2.1 - Serial Number

Product Serial Number

Always give your dealer the serial number of your Pelsue confined space ventilator product when ordering parts or requesting service or other information.




Figure 2a: Serial Number Location

The specification & rating decal is permanently embossed with a serial number. The rating decal is located at the top of the housing of the centrifugal blower as shown in *Fig. 2a*. The specification & rating decal will appear as shown to the right in *Fig. 2b*. A space has been provided below for the recording of the serial number for future reference.




Figure 2b: #1453 Serial Number Decal


3.0 - Configuration & Assembly

Upon initial receipt of the Model #1453 Centrifugal Blower, inspect the packaging for any evidence that the product may have been damaged in shipment. While unpacking the product, inspect all of the components for damage. If damage to any of the components is discovered, Alert the shipping carrier immediately of the damage to the shipment.

4.0 - Safety

The following section will address the safety precautions which must be adhered to when working with Pelsue confined Space Ventilation equipment such as the #1453 Centrifugal Blower. Any user must familiarize themselves with the information in this section before utilizing the equipment.

SIGNAL WORDS:

Note the use of the signal words **DANGER**, **WARNING** and **CAUTION** with the safety messages. The appropriate signal word for each message has been selected using the following guidelines:

- **DANGER-** Indicates an imminently hazardous situation that, if not avoided, will result in death or serious injury. This signal word is to be limited to the most extreme situations or for hidden or unseen hazards.
- **WARNING-** Indicates a potentially hazardous situation that, if not avoided, could result in death or serious injury and includes obvious and hidden hazards. It may also be used to alert against unsafe practices.
- **CAUTION-** Indicates a potentially hazardous situation that, if not avoided, may result in minor or moderate injury. It may also be used to alert against unsafe practices.

You are responsible for the safe operation of your Pelsue #1453 Centrifugal Blower. You must ensure that anyone who will operate or work around the equipment be familiar with confined space ventilation procedures. This manual will take you step-by-step through the workings and capabilities of the #1453 Centrifugal Blower and alert you to good safety and operating practices while using the system.

Remember, you are the key to safety. Good safety practices not only protect you but also the people around you. Make these practices a working part of your safety program. Be certain that everyone operating in or around a confined space is familiar with the procedures recommended and follows safety precautions. Remember, most accidents can be prevented. Do not risk injury or death by ignoring good safety practices.

- The most important safety device on this equipment is a safe operator. It is the operator's responsibility to read and understand all of the safety and operating instructions presented within this manual and to follow them. Most accidents can be avoided.
- A person must understand the operation of this equipment and be trained in it's usage before operating the equipment. An untrained operator exposes himself and others to possible serious injury or death.
- Do not modify the equipment in any way. Unauthorized modification may impair the function and/or safety and could affect the life of the equipment.
- Think SAFETY! Work SAFELY!

4.1 - Safety Alert Symbol

SAFETY ALERT SYMBOL

This Safety Alert symbol means **ATTENTION! BECOME ALERT! YOUR SAFETY IS INVOLVED!**

The Safety Alert symbol identifies important safety messages on your Pelsue Confined Space Product and in the manual. When you see this symbol, be alert to the possibility of personal injury or death. Follow the instruction in the safety message.

Why is this symbol important to you?

3 BIG Reasons: Accidents Disable and Kill.

Accidents Cost You Money.

Accidents Can Be Avoided.



Safety Precautions:

It is necessary to follow these safety precautions, each time, prior to using the product.

The Safety Precautions are not limited to, but must include the following items;

- **1.** Do not use the blower for anything other than its intended use.
- **2.** Do not wear loose clothing that can become entangled in operating machinery. Do not operate the blower without inlet or outlet grilles in place.
- **3.** Do not place fingers or any other object through inlet or outlet grilles.
- **4.** To prevent exhaust fumes from being pulled into the blower intake, never run the engine in an enclosed area and always position the blower intake into the wind.
- **5.** Always be sure to shut down the engine and extinguish all smoking materials before filling the fuel tank.
- **6.** Always be sure to fill the fuel tank outdoors or in a well ventilated area. Never start the engine if the fuel has been spilled until the spill has evaporated and there is no longer smell of gas fumes.
- 7. Never store or use gasoline within 50 feet of anything which may produce a spark or flame.
- **8.** Ensure that toxic fumes are not blown into a confined space.
- **9.** Never use this blower in any explosive environment.
- **10.** Do not leave blower operating while unattended.



! CAUTION! - Be sure the blower has been shut down and the spark plug wire has been disconnected before doing any maintenance or repair work on the blower.

! CAUTION ! - Check all fluid levels prior to operating the blower. Refer to engine manual for fluid types and required amounts.

! CAUTION! - The engine of this unit has been modified with a stop on the throttle lever. Removal of this stop may lead to an "overspeed" condition of the blower, which may cause damage to the blower wheel and/or housing and could result in injury.

5.0 - Product Operation

The following section will address the capabilities and the general operation of the Pelsue Model #1453 Centrifugal Blower. The instructions contained within this section should be adhered to each and every time the product is used. Any person tasked with installing or operating this piece of equipment should be familiar with these procedures.

5.1 - Product Description & Capabilities

The Pelsue Model #1453 Centrifugal Blower is built with a rugged steel housing and internal steel and/or aluminum components. The Pelsue #1453 Centrifugal Blower is specifically designed for confined space applications. All specifications, instructions, and procedures provided within this manual or upon Pelsue Specification Documents are based upon and only valid for usage with Pelsue accessories. The T.A. Pelsue Company can not verify equipment safety and/or compliance when utilized with anything other than Pelsue approved confined space accessories.




Figure #5.1a: #1453 Centrifugal Blower

Prior to Operation, the #1453 Centrifugal Blower should be configured and prepared according to the following guide-lines.

1. Pre-Operation Inspection:

It is necessary to perform a visual inspection, each time, prior to using the product. If deficiencies are found, remove the product from service and contact the T.A. Pelsue Company regarding repair. The following checklist coupled with *Figure #5.2a* should be used as a guide to determine whether the equipment is in good operating condition prior to usage. Equipment that is not in good condition can endanger the safety of the entrant(s) and attendant(s) during use.

The Pre-Operation Visual Inspection is not limited to, but must include the following items;

- **a.** Check that the blower inlet and outlet grilles for obstructions.
- **b.** Ensure that the exhaust and the air intake of the engine are not obstructed.
- **c.** Check the fuel and oil levels in accordance with the engine manual.
- **d.** Remove any objects around the immediate area that could be drawn into the blower.
- **e.** Ensure that the rubber feet and vibration springs are attached.
- **f.** Ensure that the spark plug wire is connected to the spark plug.




Figure #5.2a: #1453 Centrifugal Blower Pre-Operation Inspection Points

5.2 - Start-Up & Operating Procedures (continued)

2. Setup of 1453 Centrifugal Blower:

Choose a location where installation will provide suitable proximity to the work area yet minimize obstructions during use and in the event a rescue becomes necessary. Once a location is chosen;

- **a.** Place the blower on a flat, solid surface at a location 1.5 meters upwind (where possible) from the confined space, and have its inlet pointed into the wind. This will reduce the chance of contamination being blown into the confined space (Refer to Fig. #5.2b).
- **b.** To start the engine, move the fuel lever to the ON position and move the choke lever to the CHOKE (closed) position (Choke must fully close)
- c. Turn the ignition switch to the ON position and move the throttle lever to the maximum speed.
- **d.** Grasp the rope handle and pull slowly until resistance is felt. Then rapidly pull the cord to overcome engine compression and prevent kickback.
- **e.** After the engine has started, gradually move the choke lever to the OPEN position. The engine speed can now be adjusted to the desired speed by moving the throttle lever.
- **f.** To shut down the blower, turn the ignition switch and the fuel lever to the OFF positions.

!!! Do not move the choke lever to the CHOKE position to stop the engine. Backfire or engine damage may occur. !!!




Figure #5.2b: Centrifugal Blower Setup in Confined Space
