The Pro Pack contains a SR 100 M/L half mask Air Purifying Respirator (APR), a particulate filter SR 510/P100 and a chemical cartridge SR 232 OV/SD/CL/HC/HF.

This combination of filters provides protection against all types of particulate pollutants (SR 510/P100) and from certain levels of organic vapor/acid gases suitable for protection during spray painting, pesticides, agriculture, construction and transportation.

All delivered in a suitable storage box.

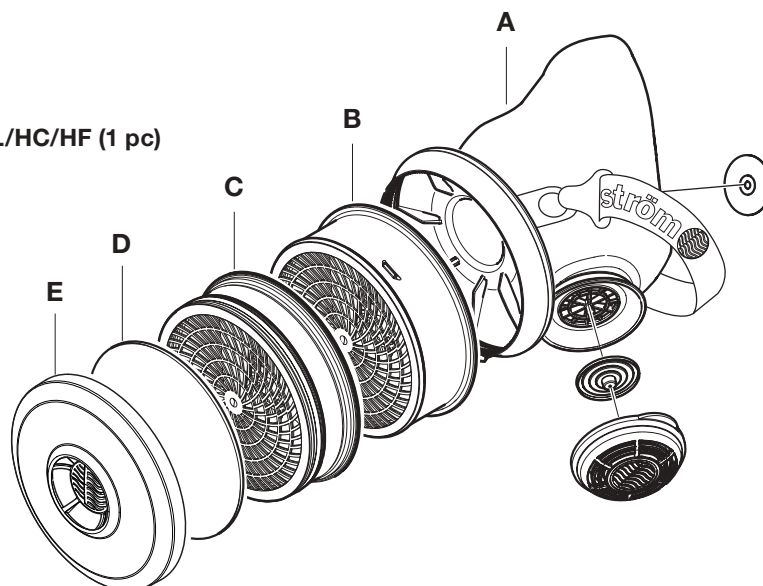

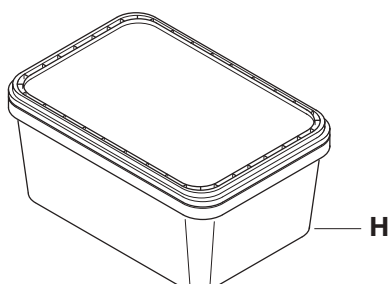
