Subj: BUOY, LIFE RING; PRIVATE LABEL RENEWAL

We have reviewed the materials you have submitted with your emails dated July 24, 2019 through August 7, 2019, requesting to renew the approval of your life ring buoy MRD030. Based on our review of the documents you submitted and the approval of the original Datrex life ring buoy model DX0352D, we have approved the private label renewal of the model MRD030, Coast Guard approval number 160.050/B127/0 and 160.150/B2/0. The Certificates of Approval (COAs) are enclosed.

This approval is contingent upon the approval of the Datrex life ring buoy model DX0325D, Coast Guard approval numbers 160.050/127/0 and 160.050/2/0. The COAs will remain valid for duration of the approval for the original Datrex device, unless we suspend, withdraw, or terminate it. Terms of approval are on the reverse of the certificate. Any changes or alternation of components, construction or manufacturing location of the product may require a product to undergo additional testing, or requalification in order to keep its approval.

In conjunction with this review, we have created a superseded COA under Coast Guard approval number 160.150/2B dated January 29, 2014 to January 29, 2019, the date of the previous certificate's expiration. This COA was created based on the approval of the Datrex life ring buoy model DX0325D, which was valid during that time frame, and the quality control system which was followed during that time frame.

As a condition of this approval, products indicated on the COA must be permanently and legibly marked in accordance with 46 CFR 160.050-6 and the word "SOLAS" for the life ring buoy approved to 46 CFR 160.151. The product must also have the Underwriters Laboratory (UL) label, as required by UL.

Approval is contingent upon continued participation in the "follow-up" program established with UL. It is your responsibility to ensure that the testing is conducted in accordance with USCG regulations and to submit the annual report required by 46 CFR 159.007-11. You may submit a single annual report to cover all USCG approved lifesaving appliances produced in a year.
